Subject: Demand Charter

Respected Sir,

Greetings from HFUCTO

You are aware that the teachers of higher education are facing numerous problems for a long time. You are also aware that we have been taking up these matters with UGC and MHRD on a regular basis. Even in Haryana state our different associations representing thousands of teachers working in universities and colleges tried to approach the officers and minister concerned many a time but partially succeeded to sensitized on our long pending issues. Now, under the banner of All India Federation of University & College Teachers' Organizations (AIFUCTO), the national apex body of state university & college teachers, thousands of teachers from all over India including Haryana is on mass casual leave on 5th October, 2016 (today) to press for fulfillment of our demands. The action is fully supported by HFUCTO. Haryana Federation of University & College Teachers' Organizations (HFUCTO), is the state apex body of state university & college teachers.

The demands are following:

- 1. Early and Teachers' friendly 7th UGC Pay Scales.
- 2. Complete Scraping of API to ensure promotion of teachers.
- 3. The 4th Amendments to the UGC Regulations 2010,has also failed to address the burning problems in an appropriate manner. It is note-worthy that the Ministry has maintained a complete silence on the issue of rational Roll out of API which was recommended by UGC in May June, 2014. The 4th amendment has brought the CAS process to stand still in the absence of appropriate roll out.
- 4. Withdraw Pension Scheme-2004 & Ensure Pension for all teachers.
- On the issue of exemption from NET to the Ph. D degree holders, we once again demand that there should be no distinction between pre and post 2009 degrees, both for exemption from NET and grant of research degree increments.
- To fill up all vacant posts at permanent basis in universities and colleges in accordance with UGC Regulations, 2010.
- 7. Roll Back CBCS & CU Bill 2013 as these would vitiate our higher education.
- 8. Extend dates for completion of RC/ OC up to December'2016. This is absolutely necessary as many teachers were unable to fulfill the requirement for no fault of their own.
- UGC Pay Scales for all categories of Teachers, Librarians, DPEs, Academic & Administrative Staff.
- 10. Stop Budget Cut & Commercialization of Higher Education.
- 11. Consult Teachers' Organizations on Education Policy.
