In the above referred matter, you are hereby informed that under New Pension Scheme the contribution of State and the College Management will be in the same proportion as the contribution by respective parties in respect of their salary i.e 95 % will be borne by the State Govt. and 5% will be contributed by the Management of the colleges. On the basis of information provided by the colleges, regarding the deduction of amount under New Pension Scheme upto 31.3.2015, the State Govt. share and the Management share have been calculated which is annexed herewith for confirmation. You are requested to confirm and certify that the entries are properly calculated.

Further, the share of the State Govt. shall be released only after the certification, by the Management in the salary bill of the respective colleges, that they have deposited 5% of their share.

Further, the Principal of Aided Colleges shall registered themselves with NSDL for issuance of PRAN No. at their own level, in respect of the employees appointed against sanctioned posts on or after 1.1.2006.
