The Chief Electoral Officer, Haryana, Chandigarh. Sub: Regarding Election Duty as per pay and status.

Respected Sir,

Most respectfully we wish to submit that Executive Committee of HFUCTO discussed in detail the issue of election duty of University and College Teachers of Haryana in Assembly/Parliamentary/Panchayat/Local Bodies etc. and decided to write you in this regard.

It has been observed that the studies of students are affected by the election duty of the teachers particularly after the introduction of the semester system in the universities and colleges of the state. In semester system the teaching and evaluation process is continuous throughout the year. Also due to lack of recruitment, the no of teachers have reduced up to 50% and work load on teachers have increased substantially. The HFUCTO very sincerely believes that it will be in the fitness of things that any election duty of the university and college teachers should be avoided in order to respect the unique processes of higher education.

However, if there is any emergency situation, the HFUCTO would most respectfully like to submit the following with respect to election duty of the teachers in higher education. There are following categories of pay scales of teachers in Universities and Colleges of the state.

- (i) Assistant Professor Rs. 15600 33400 with grade pay of Rs 6000, 7000 & 8000.
- (ii) Associate Professor Rs. 37400-67000 with grade pay of Rs 9000-00
- (iii) Professor Rs 37400-67000 with grade pay of Rs 10 000 & 12000.

It has been observed in the past that polling duties of the teachers in higher education are not assigned according to their pay scales and seniority and they are forced to work under the officers who are drawing much less pay scale and junior. It becomes difficult to work by the teachers who are already under great pressure due to increased work as mentioned above and typical nature of the job.

We want to bring to your kind notice some additional facts as given below.

- 1. In terms of article 324 (6) of the constitution of India read with section 159 of the said act, the dignity to the status of the persons deployed for election duty and assignment of responsibilities has to be maintained.
- 2. In chapter III relating to polling personnel under 2.7 of hand book for returning officer, it is stipulated that the seniority of the official should be taken in to account in every case but it is ignored most of the times.
- 3. Hon'ble Punjab and Haryana High Court in the judgment on civil writ petition no. 6895 of 2004 (Punjab & Chandigarh College Teachers Union and others v/s election commission of India and others) observed that the Election Commission as well as the State Electoral Agencies would keep due regard to the guidelines and ensure compliance to the concept of seniority as far as possible.

In view of the above, the HFUCTO EC request you that the teachers working in higher education (Universities, Govt. aided colleges & Govt. colleges) should not be put on election duty. However if the teachers are at all required for assigning polling duties, due regard be given to the concept of seniority on the basis of Pay Scale/Status/Designation.

You are also requested to take necessary action and direct the Returning Officers accordingly.

Subject : Appointment of Presiding Officers and Polling Officers - Declaration of results.

Sir,

Under Rule 21 of the Haryana Panchayati Raj Election Rules, 1994, the Returning Officer (Panchayat) shall appoint Presiding Officer for each polling station and such Polling Officers or Officials to assist the Presiding Officers as he thinks fit. First proviso to sub-rule (1) of Rule 21 however, provides as follows :--

"Provided that no person, who is not a Government servant or servant of a authority under the Municipal Law or any public undertaking under the Government, shall be appointed as Presiding Officer."

It would mean that Government Servant and employees of authority under Municipal Law i.e. Municipal Committees, Municipal Councils and Municipal Corporation and employees of Government public undertaking can be appointed as Presiding Officer. Employees of authority under Panchayat Acts and other Acts cannot be appointed as Presiding Officer and employees of Societies, Associations, Federations etc. who are not covered under the definition of Public Undertaking under the Government, also cannot be appointed as Presiding Officer.

In view of the provisions contained in Rule 21, there is bar to appoint Class-III (Group-C) officials of the Government as Presiding Officers.

So far as the provisions relating to declaration of results are concerned. Rule 70 of the Haryana Panchayati Raj Election Rule, 1994 provides that the Returning Officer (Panchayat) or the Assistant Returning Officer (Panchayat) shall declare to be elected the candidate for the office of Panch. Similarly, the result of Sarpanch shall also be declared by the Returning Officer (Panchayat) or the Assistant Returning Officer (Panchayat). However, in cases where there are more than one polling stations for a Gram Panchayat (Sabha Area) the fesult sheet for the office of Sarpanch shall be sent to the Polling Station presided over by the Presiding Officer nominated by the District Election Officer for the purpose of declaring results. Since the Returning Officer (Panchayat) or the Assistant Returning Officer (Panchayat) are competent to declare the results under Rule 70 of the Rules ibid, the Presiding Officers who are Group-B officers may also be appointed/designated as Returning Officers (Panchayat) and the Group-C officials, who have been appointed as Presiding Officers be declared/appointed as Assistant Returning Officer (Panchayat) so that these Presiding Officers after being appointed as Returning Officer (Panchayat) or Assistant Returning Officer (Panchayat) as the case may be would be able to

SC judgement on deployment of Public Sector employees on

election duty.

Election Commission' letter No. 576/3/95-J.S.-II Dated: 17th July, 1996 addresse

to Chief Electoral Officers of all States and Union Territories.

Subject: Judgment in Civil Appeal No. 6026 of 1993 before Supreme Court (Election Commissio of India vs. State Bank of India Staff Association, Local Head Office, Patna and others) and in Civ Appeal No. 4611 of 1989 (Election Commission of India vs. Northern Zone Insurance Employee Association) - regarding.

I am directed to invite your attention to the Commission's letter No. 509/81/93-J.S.-II, dat 08.02.1995 (addressed to the Chief Electoral Officers of Bihar, Arunachal Pradesh, Gujar Manipur, Maharashtra and Orissa and letter no. 576/3f95-J.S.-II, dated 20.04.1995 (addressed to other Chief Electoral Officers) forwarding therewith a copy of the judgment and order passed by 1 Hon'ble Supreme Court on 07.02.1995 in the above Civil Appeals and also to invite your attention para 2.2 of Chapter III of the Handbook for Returning Officers, 1994 edition (Reprint 1996).

2. In the said order the Hon'ble Supreme Court has categorically held that only the employees of Central and State Governments and the employees of the local authorities covered within the sco and ambit of Article 324(6) of the Constitution and Section 159 of the Representation of the Pec Act, 1951 can be deployed on election duties as Presiding Officers, Polling Officers etc. Supreme Court, therefore, granted exemption from election duties to the employees of the Sink Bank of India and the Life Insurance Corporation, as they are not the employees of the Government or local authorities but are the employees of the statutory companies/corporations as public sede undertakings.

3. It has been observed by the Commission during the last general elections to the House of People and certain State Legislative Assemblies, that despite the above categorical pronouncenter of the Hon'ble Supreme Court on the subject, many District Election Officers/ Returning Officers I deployed employees belonging to public sector undertakings under the Central or \$44 Governments or employees of other statutory bodies, like, Universities, teachus and non-teaching staff of government aided colleges and schools run b registered Societies, etc., on the above mentioned election duties. In many cases, persons either individually or through their associations/unions approached the Hon'ble Supi Court and various High Courts and the Commission had a difficult time in explaining to the Hc courts the lapse on the part of the election authorities in making such deployment on election during Apart from the embarrassment which the Commission and the election authorities had to face b the Hon'ble Courts, that often resulted in last minute problems as the election authorities his make alternative arrangements in place of the petitioners who were exempted by the Hon'ble C from performing those duties. In addition, that also resulted in a lot of unnecessary and avoid expenditure on the engagement of the Counsel, etc. to defend those cases.

4. In order that such lapses do not occur in future, the Commission desires that all District Elechic Officers, Returning Officers and other election authorities concerned should be immedia informed once again of the above judgment and order dated 07.02.1995 of the Hon'ble Supre Court. They should be instructed to Scrupulously observe in future the said order of the Hon't Supreme Court in the matter of deployment of staff on election duties as Presiding Officers, Pollin Officers, etc. Any deviation there from will be seriously viewed by the Commission.
