(i) In advertising 362 positions of Assistant professors on contract basis on a consolidated remuneration of Rs. 21600/- per month in case of qualified persons and Rs. 15000/-
		for those in whose cases the condition of NET/SLET/M. Tech. etc. is required to be relaxed wherever NET/Ph.D. candidates are not available out of the Unforeseen Expenditure/ relevant Budget Head under Self-Financing Scheme and provide them in various University Teaching Department/Institutes/maintained Colleges to ensure smooth teaching. 		Since no remuneration for minimum pay scale to guest faculty in the affiliated colleges has been prescribed by the University. The remuneration prescribed by the University for the Teaching Departments on the campus shall be circulated among all the affiliated colleges.
10	The State Govt.as well as the university has made examination duty mandatory. We request you to seek options from teachers for examination and evaluation duty. This particular suggestion was an integral part of the HCTA/HGCTA combined 'Roadmap To quality Education' submitted to you prior to Jan. 28,2011 state level seminar, However, we regret to say that regarding examination reforms, our suggestions have been adopted selectively by the university administration.
